5.2 Report on status of Construction Manager Selection process and conditional approval of selecting-Nations Group- Steve Bauer, with Nations Group, stated the RFP was advertised twice in the newspaper and also electronically to the dodge report. They had a non- mandatory meeting and there were 6 different construction firms attended. Three Construction firms sent in their bids for this project; Garmong Construction Services, Pepper Construction, and Wilhelm Construction. The committee held interviews September 7, 2018 and had a scoring sheet for each of these construction firms that turned

in a bid. Pepper Construction received an average of 81.6 points, Wilhelm Construction received an average of 88.6 points and Garmong Construction received an average of 94.6 points. With recommendation the CIB Board select Garmong as the CMC for this project and enter them in immediate negotiations construction contract. **Motion: Action: Approved, Moved by: Greg Gibson, Seconded by: Mayor Duke Bennett, Passed: all ayes.**


5.3 Update on status of Construction Manager Contract and approval authority for CIB President to negotiate and execute AIA A133-2009 with selected Construction Manager- Kroger Gardis & Regas, LLP- Steve Bauer, with Nations Group, stated there is a draft for an AIA A133-2009 document, a construction contract between the owner and constructor.
